In doing this, you can instill public confidence through certified third party review of recycler practices.



Responsible Recycling Practices R2:2013 is an updated version of the R2 standard that keeps recyclers accountable, offers a seal of approval for responsible recyclers and waste management companies, protects employees throughout the supply chain, and protects the people in the developing world who are exposed to the hazards of e-waste. Supported by the Environmental Protection Agency (EPA), R2 is a set of principles and specific practices that recyclers disassembling or reclaiming used electronics equipment must adhere to. These guidelines call for the establishment and use of a management system that covers environmental, worker safety, and public health practices on-site and downstream management of end-of-life equipment and material (EPA.gov, Responsible Recycling Practices).





R2 ensures that the recycler complies with environmental, health, and safety legal requirements that are applicable to the recyclers' operations. 'Going Green' is not just a trend or initiative asserted by environmental protection groups anymore, it has become a business strategy for promoting environmentally responsible

practices to conscious customers while positively impacting the bottom line.



In order to become 3rd party certified to R2:2013, an e-waste company must

also be certified to ISO 14001 and OHSAS 18001 and/or RIOS. While ISO 9001 is not necessary for R2 certification, an e-waste company would benefit from implementing one to help meet the Quality Assurance requirements within the R2:2013 Standard. R2:2013 certification is a two-stage audit process, as are most management system standards.
